He added that to date, SEDANIA's ongoing efforts of managing about 72 Gigawatt-Hours of energy by retrofitting over 400 buildings culminated in electricity savings of 107 Gigawatt-Hours.

This effectively avoided about 74,000 tons of carbon emissions, which is also equivalent to having planted 950,000 new trees.

"We are poised to complement our healthy pipeline of ongoing projects and play a bigger role in boosting Malaysia's sustainability standing by initiating more projects from various different industries as well as possibly diversifying into projects for other types of businesses such as SMEs," Ruppert said.

Most of these projects are undertaken based on a zero-capital expenditure model where SEDANIA bears all initial costs and risks while in return, clients would be invoiced every month throughout the contract duration a portion of the achieved energy reduction.
